## FORMULATION OF MUNAZIM COMPANIES AS PER DIRECTIONS OF THE SAUDI GOVERNMENT FOR HAJJ OPERATION-2024.

I am directed to refer to the subject cited above and this Ministry's letters of even number dated 11<sup>th</sup> January, 17<sup>th</sup> January and 26<sup>th</sup> January 2024 on the subject noted above.

- 2.. It is hereby reiterated that as per instructions of Saudi Government, existing quota holder HGOs have to form clusters / groups to comply with the condition of minimum quota of 500 pilgrims. Most of the HGOs have submitted Munazzam companies which have been forwarded to SECP and these Munazzam companies have been registered with SECP. Accordingly, list of 89 Munazzam Companies has been uploaded on the website of this Ministry on 9<sup>th</sup> February 2024 and e-hajj portal of about 60 Munazzam companies in Saudi Ministry of Hajj, KSA has also been activated. Saudi Government has directed to speed up hajj arrangements and as per latest information, the last date for making contract in KSA is 3<sup>rd</sup> week of February 2024.
- In spite of repeated reminders as referred above as well as regular meetings with HOAP, 23 HGOs; as per list attached, have not yet become part of any Munazzam Company to meet the condition of minimum quota of 500 pilgrims as per Saudi Government instructions. These companies are hereby finally directed to submit their all relevant documents by 14<sup>th</sup> February, 2024 for formulation of Munazzam Companies, for registration with SECP failing which they will not be eligible for Hajj operation and this Ministry has the right to dispose of their hajj quota accordingly.
