Subject: **HAJJ OPERATION – 2024 UNDER PRIVATE HAJJ SCHEME.**


I am directed to refer to the subject noted above and to say that this Ministry vide letters of even number dated 22-11-2023, 28-11-2023, 7-12-2023, 11-01-2024, 17-01-2024, 19-1-2024, 26-1-2024, 1-2-2024 and 12-2-2024 requested time and again for provision of certain documents for allocation of Hajj Quota/formulation of Munazzam Companies as per Saudi Taleemat.

2. In spite of repeated letters/reminders as referred above, 17 HGOs; as per list attached, failed to provide requisite documents for allocation of Hajj Quota and formulation of Munazzam Companies. In case of further delay such HGO shall not be able to meet the deadline given by Saudi Government.

3. Ministry of Hajj, KSA has categorically stressed upon completion of contracts through On-line Portal by 25th February 2024 as per new digitized system and organizers should promptly transfer the designated amounts of Hajj Pilgrims to a Bank Account associated with Pakistan Hajj Mission.

4. HGOs; as per list attached, are finally directed to submit documents/Munazzam Companies by **19th February 2024 before 11.00 am in HGO Section.** The defaulter HGOs shall not be eligible to participate in Hajj Operation and Hajj quota of these HGOs shall be disposed of by this Ministry accordingly.

5. This may be noted as final notice in this regard and no further reminder will be issued.
