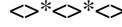

TENDER / INVITATION FOR BIDS FOR CELEBRATION OF HOLI-2021

Sealed Tenders from reputed Firms having Income Tax / GST Registration are invited for the provision of following services on celebrations of **Holi-2021** function, in Islamabad/Karachi/Hyderabad/Sukkur:-

A.

- i. Reservation of Hall, Catering/Water proof Canopies and sitting arrangements **for 600** persons alongwith arrangement for Sound System, Light, AC and Generator.
- i. Designing, preparation and installation of Backdrop (15X30), Standees (3x8) / Steamers / Banners Panaflex, transportation and installation. Attractive designs at least five relating to the Holi both in hard and soft forms must be attached with the quotation. SMD Screen for Stage Backdrop.
- ii. Preparation of the Rangoli with different colours. Quotation without attractive designs of Rangoli would not be accepted.
- iii. Printing of Invitation Cards, fine quality, hard card, 350 gm weight, size 7.5' x 5.4", four colours, as per approved specimen and envelopes.
- iv. Arrangements of Artists to present Tableaus (3 to 4) with reference to Holi-2021. Profile of Artists / CD containing the clips to see the quality of performance must be attached.
- v. Arrangement of Transport for the shifting of invitees from outstation/local to place of function and back.
- vi. Arrangement of Stage Secretary, fluent in English/Urdu, having at least 3 years working experience of handling such functions of 500 persons / Anchorperson of electronic media-PTV. CV must be attached.
- vii. Arrangement of Flower/Interior Decoration (like cloured cloths etc) of the hall.
- viii. Fireworks related to Holi-2021 celebration
- ix. Arrangement of Stage Setting, Lightening and DJ sound System.
- x. Video coverage and still photography of the function. Two cameras be used so that no part of the function is missed and audience is also shown at the same time.

B. **Arrangement of Dinner with Setup for 600 persons:** Stylish Dera/Side Catering/water proof Canopies, floor carpets, red carpet runners alongwith decorations and lightening, fans etc. **VIP corner**, with sofas/tables, **total 100 persons**, Seated / Serving of dinners to VIPs through waiters. Dinner for **500 general participants** on round tables setup with standing buffets, Good crockery, Cutlery, Water Coolers with glasses. **Firm would be responsible to take NOC from district administration to carry out the job.**
