- 4. An applicant may apply for more than one posts separately.
- 5. All the candidates applying for the above-mentioned posts (s) shall be entitled for general relaxation of five years in upper age limit as per rules. Any other relaxation in upper age limit will be given as admissible under the rules.
- 6. The candidates shall provide original documents along with set of attested copies of the degrees / Certificate by HEC/ recognized Board/ Institute and any other documents at the time of interview. The information given by the applicants will be verified and in case of any false or forged information/documents by the candidates, the Ministry of Religious Affairs & Interfaith Harmony reserves the right to cancel candidature of the particular candidate even after employment. Legal action will also be taken against such candidate.
- 7. The Ministry of Religious Affairs & Interfaith Harmony reserves the right to increase or decrease the number of posts as per requirement against any post without assigning any reason or cancel the recruitment process at any stage.
