2. All the HGOs were directed to upload the data on HGO's-MIS vide this Ministry's letter dated 06.06.2022 (copy enclosed). The HGOs have not uploaded the data and hence it is not known if Hujjaj of HGOs have arrived or not, which is against the rules/policy of the Ministry i.e. SPA-2022 and consequently Monitoring of HGOs is impossible.

3. All HGOs are once again directed to upload the data of Hujjaj on HGO's-MIS immediately. In case of non-compliance, the Ministry shall take appropriate action as per rules/policy.



Subject: MONITORING OF HGOs IN MADINAH MUNAWARAH, HAJJ-2022

It is submitted that the undersigned is tasked to monitor Hajj Group Organizers (HGOs) in Madinah Munawarah; for monitoring it is required that the HGOs upload data of their Hujjaj on HGO-Management Information System (HGO-MIS). The HGOs are bound by the letter of the Ministry dated 6th June, 2022 to upload the data on the HGO-MIS. The data is generally uploaded well in time, before of the arrival of the Hujjaj. However, this year till date the HGOs have not uploaded the data and hence it is not known if Hujjaj of the HGOs have arrived or not.

2. This shortcoming on part of the HGOs has been brought in the notice of the Coordinator of Hajj Organizers Association of Pakistan (HOAP), as yet he has not forced the HGOs to comply orders of the Ministry.

3. In view of the above, it is requested that the HGOs may be directed to upload data of their Hujjaj on HGO-MIS without any delay.


